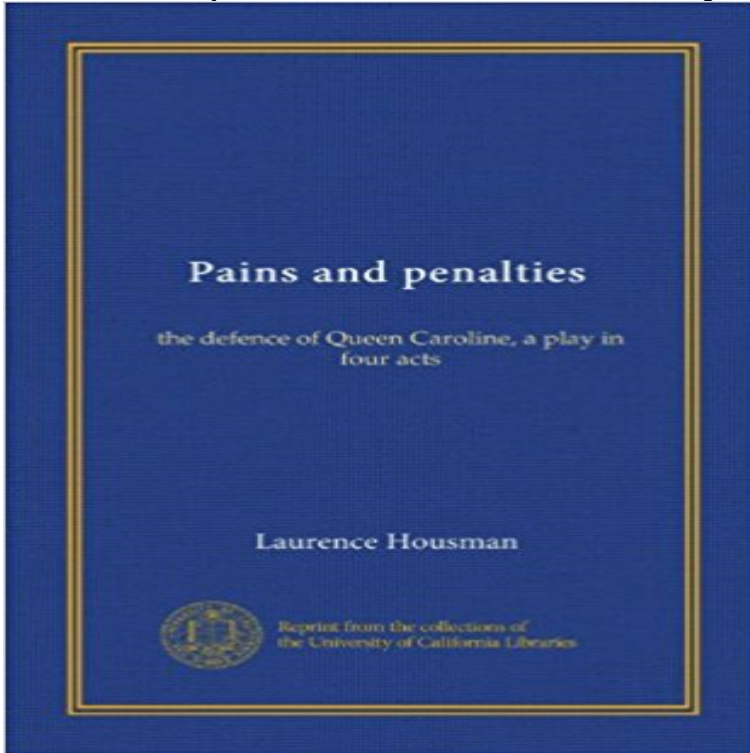


Pains and penalties: the defence of Queen Caroline, a play in four acts
