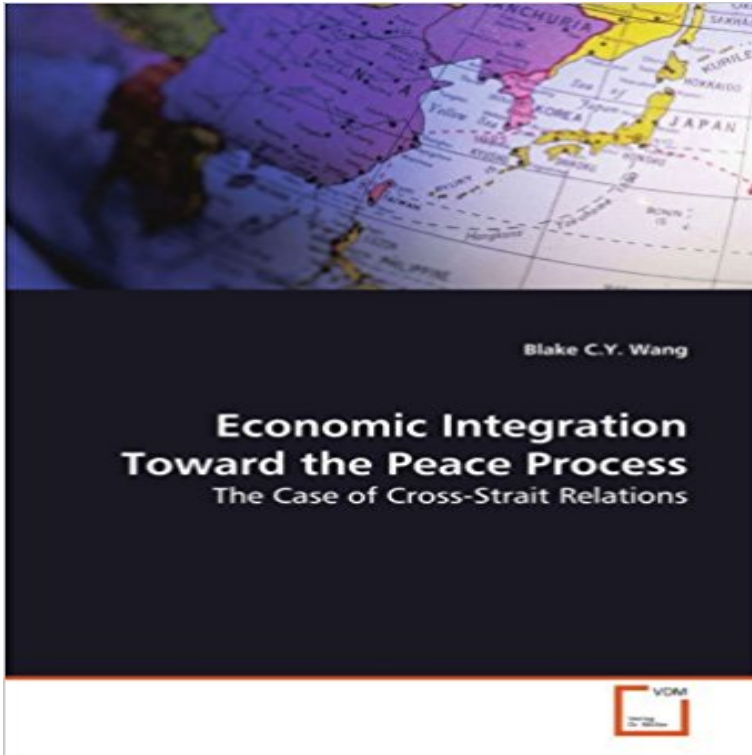


Economic Integration Toward the Peace Process: The Case of Cross-Strait Relations
