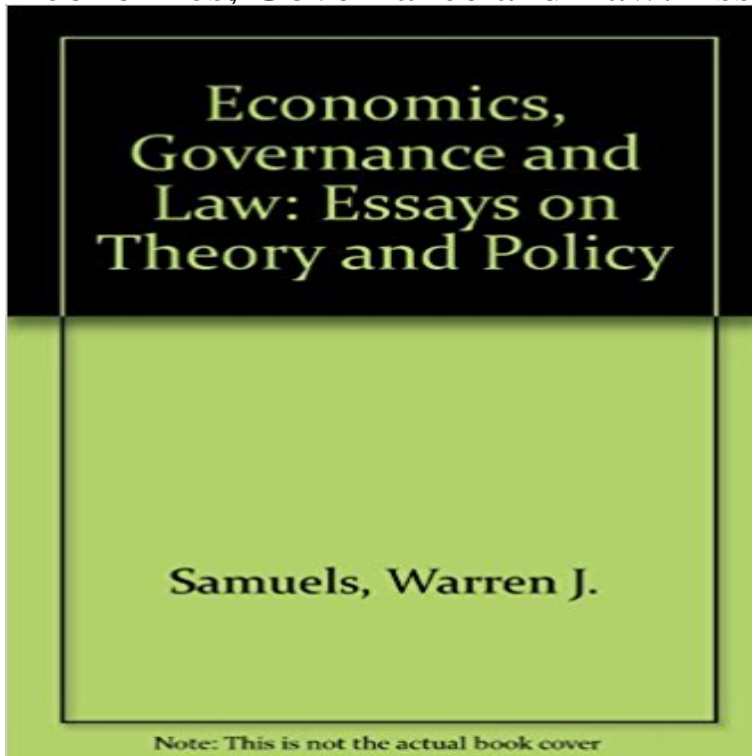


Economics, Governance and Law: Essays on Theory and Policy
