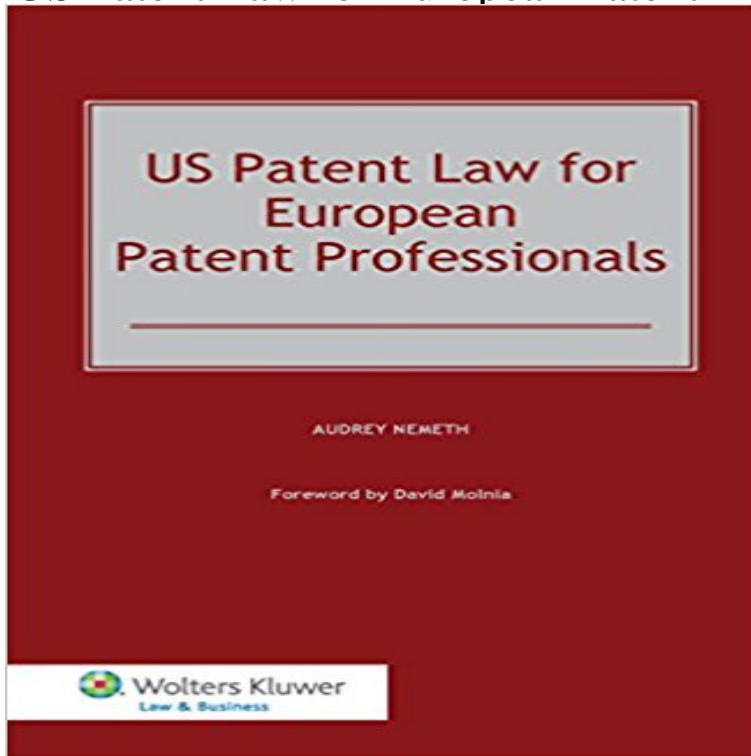


US Patent Law for European Patent Professionals
