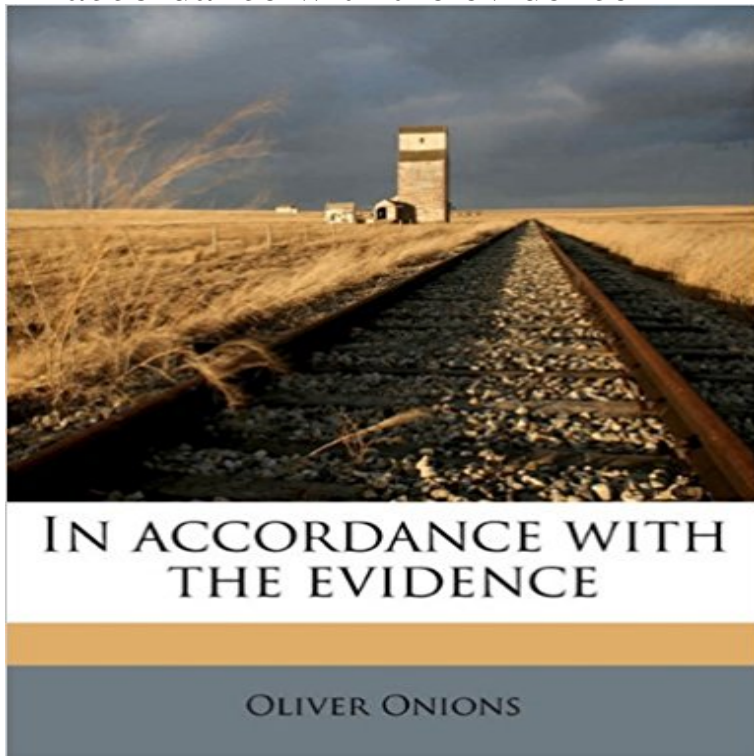


## In accordance with the evidence
