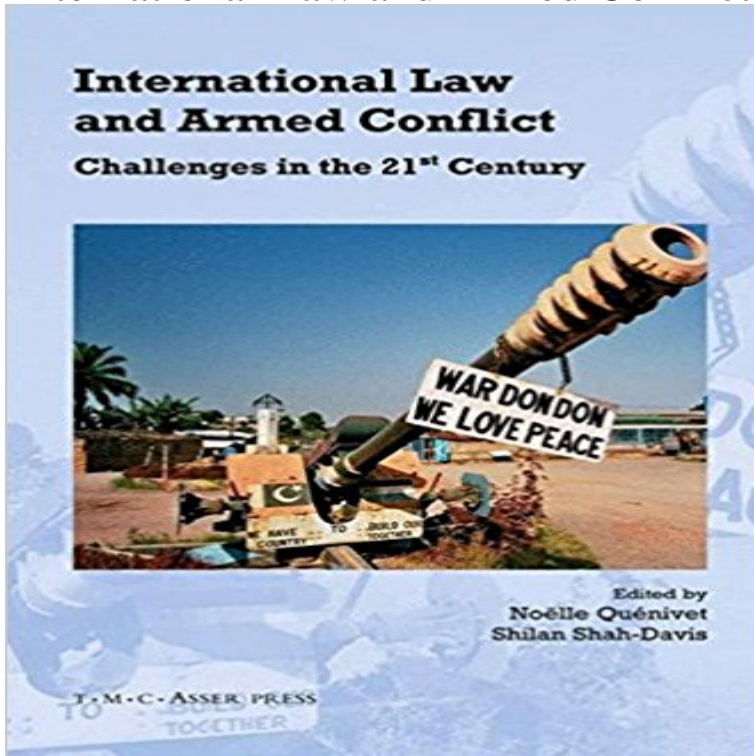


International Law and Armed Conflict: Challenges in the 21st Century
