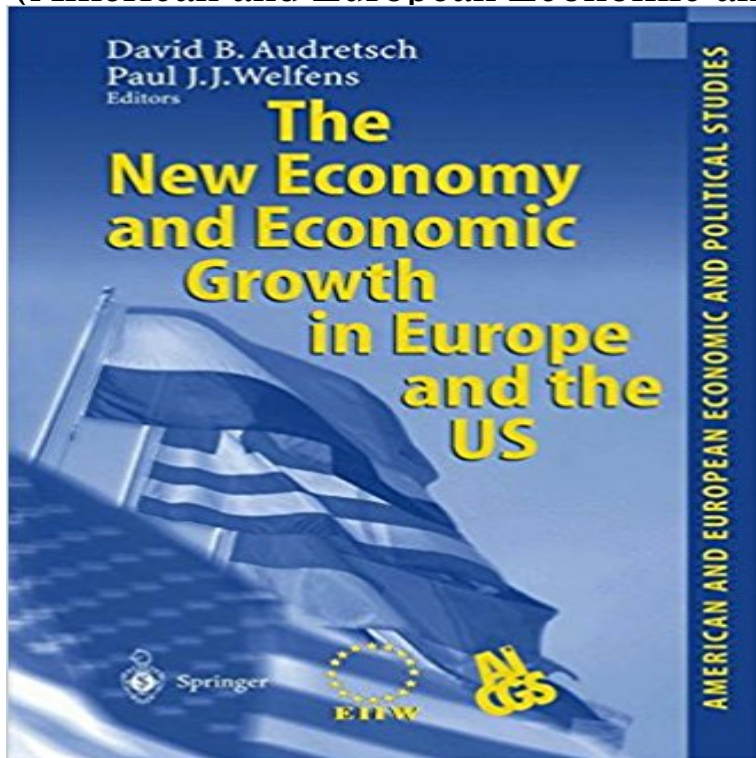


The New Economy and Economic Growth in Europe and the US (American and European Economic and Political Studies)
