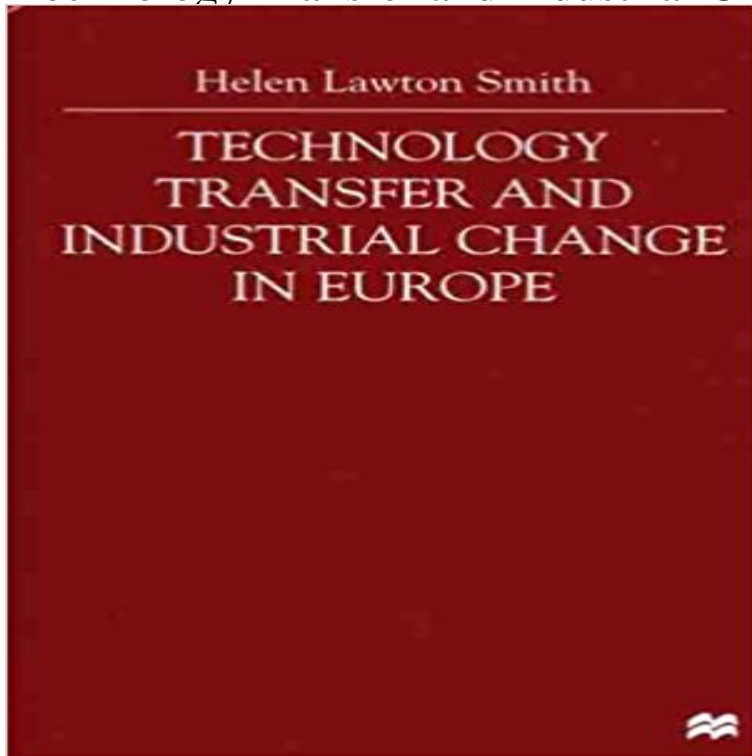


Technology Transfer and Industrial Change in Europe
