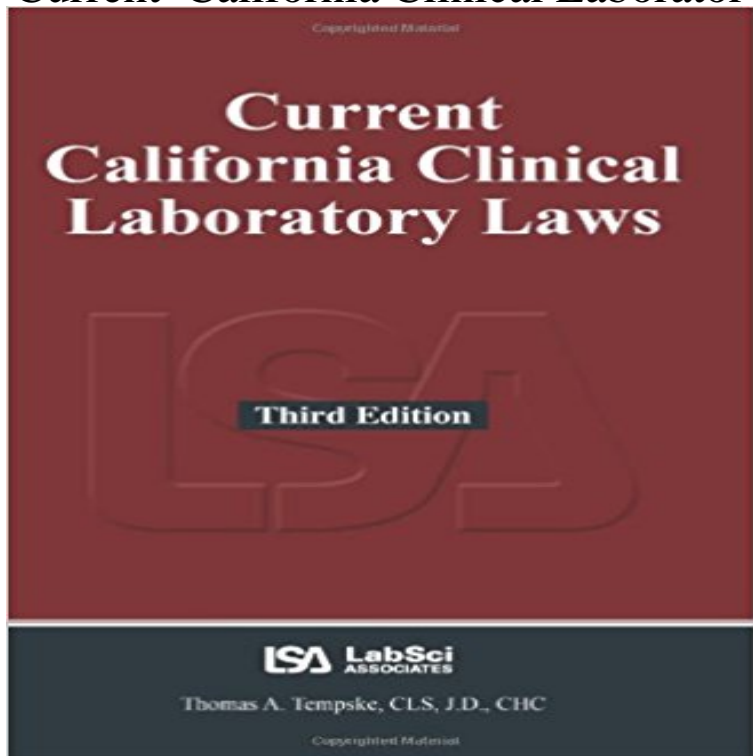


## Current California Clinical Laboratory Laws
