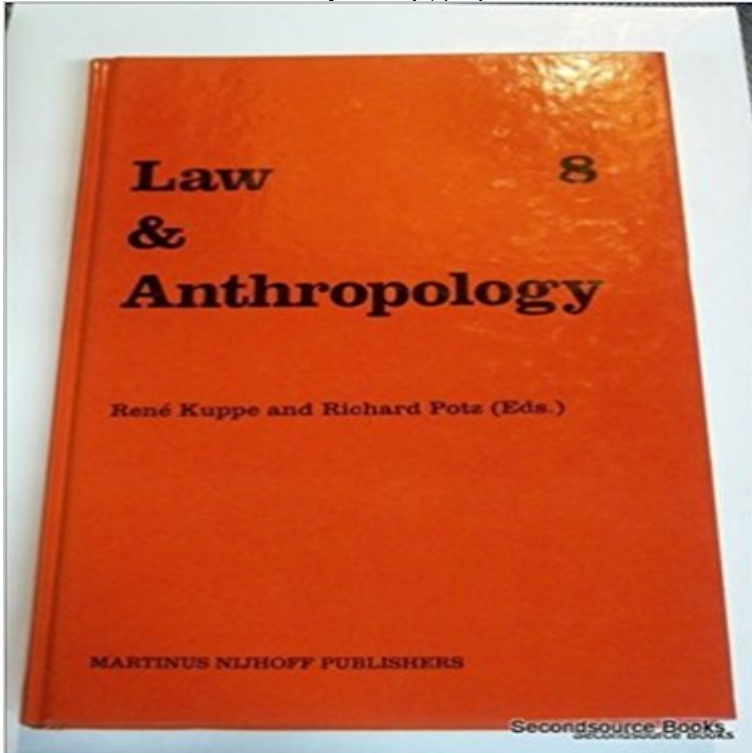


## Law and Anthropology (Law & Anthropology) (v. 8)
