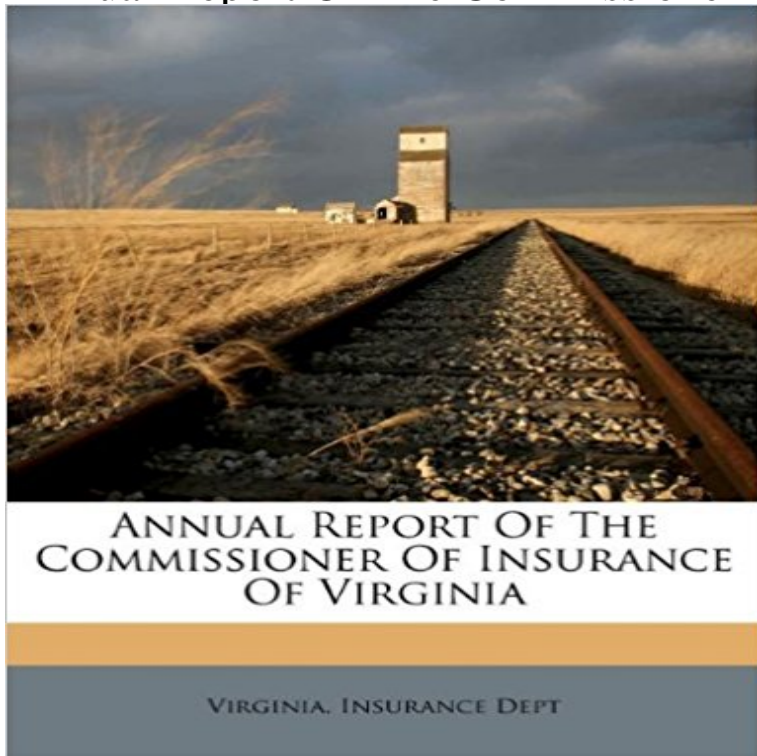


# Annual Report Of The Commissioner Of Insurance Of Virginia
