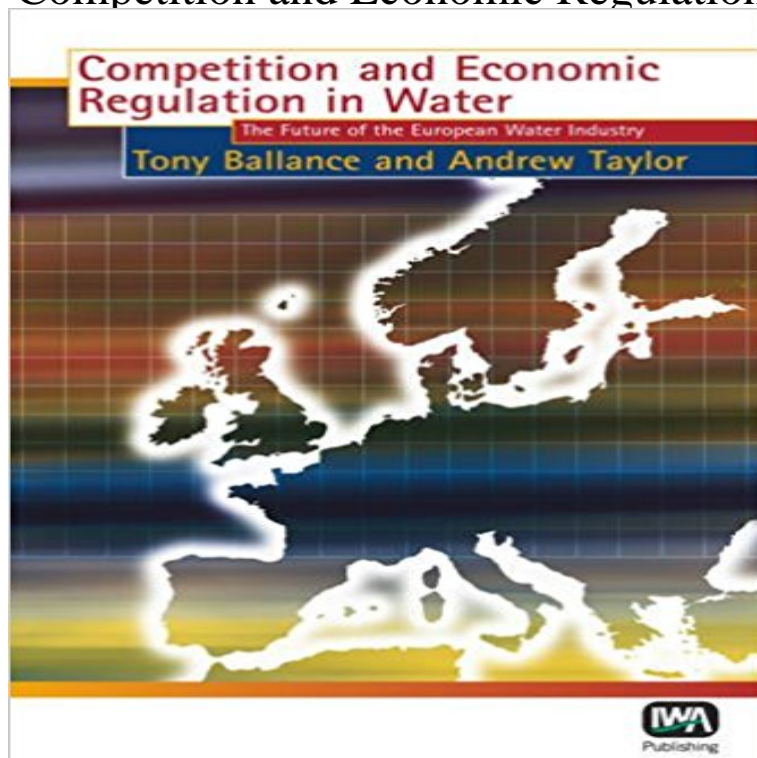


## Competition and Economic Regulation in Water
