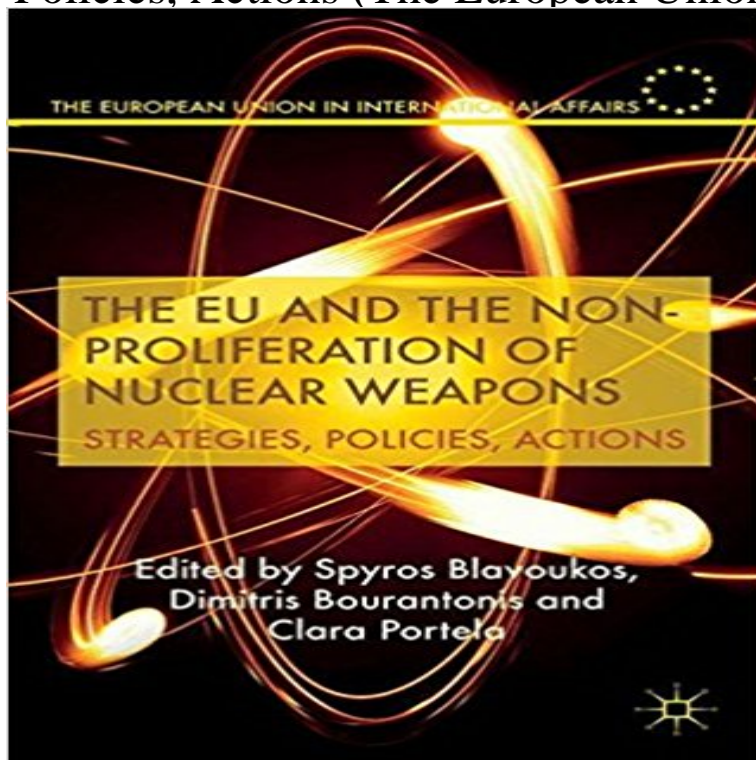


## The EU and the Non-Proliferation of Nuclear Weapons: Strategies, Policies, Actions (The European Union in International Affairs)
