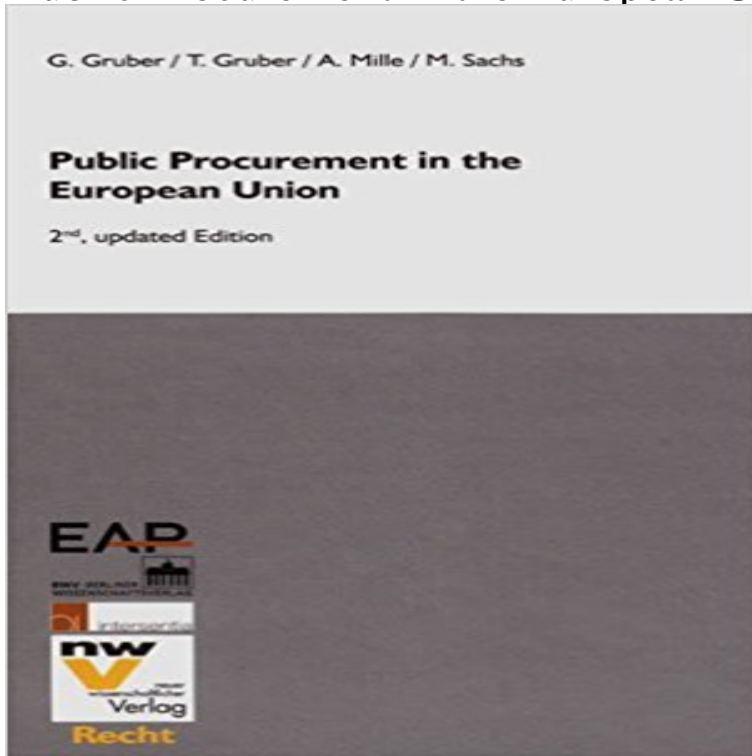


# Public Procurement in the European Union: Second Edition
