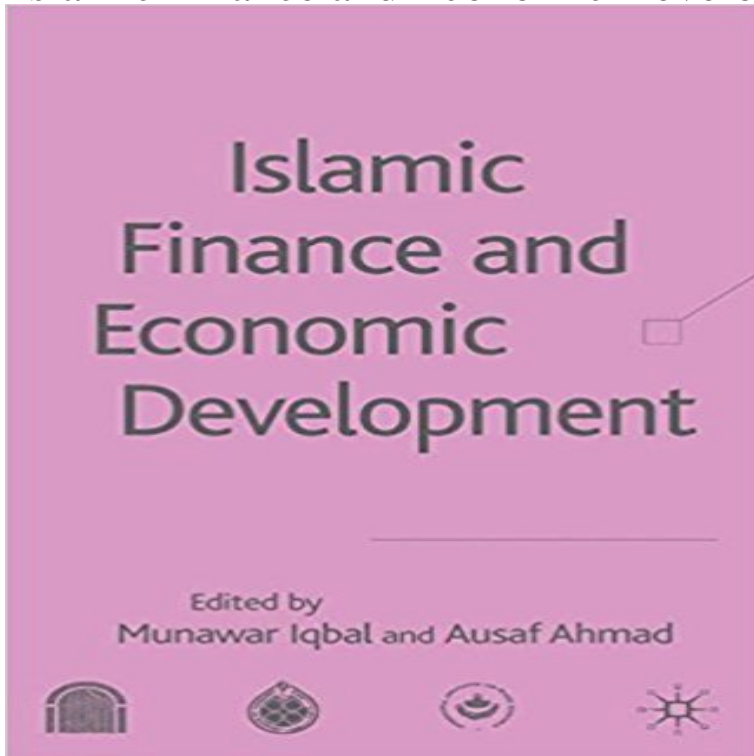


Islamic Finance and Economic Development
