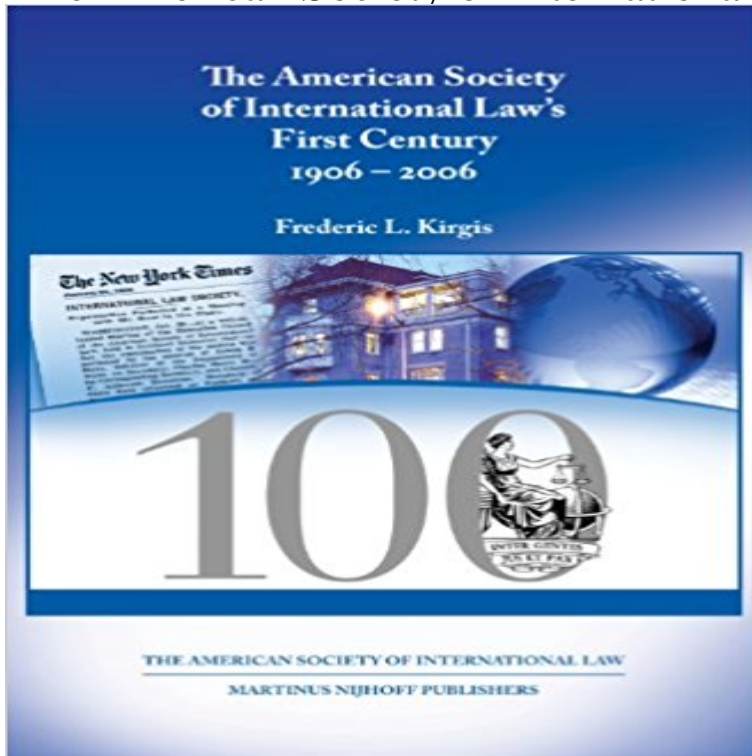


# The American Society of International Laws First Century: 1906 - 2006
