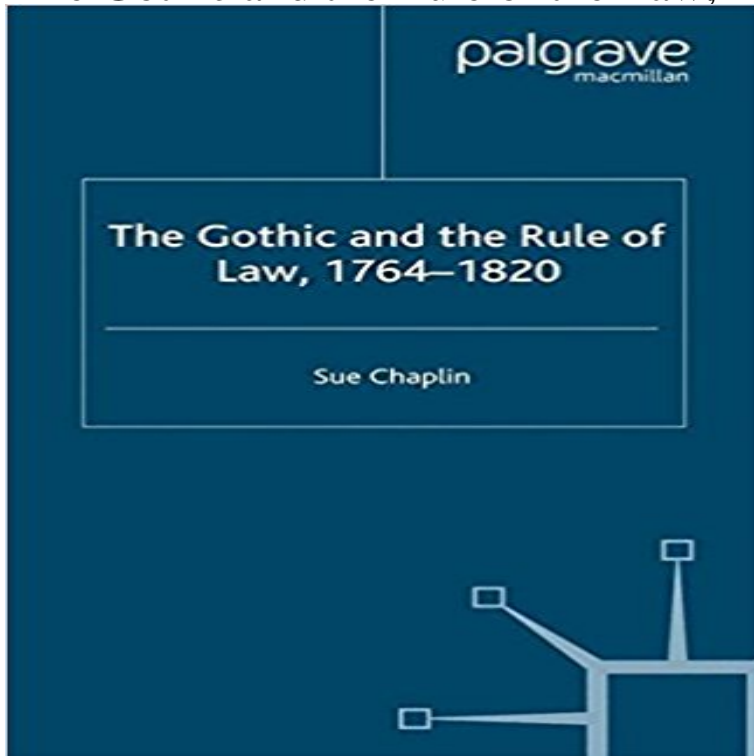


## The Gothic and the Rule of the Law, 1764-1820
