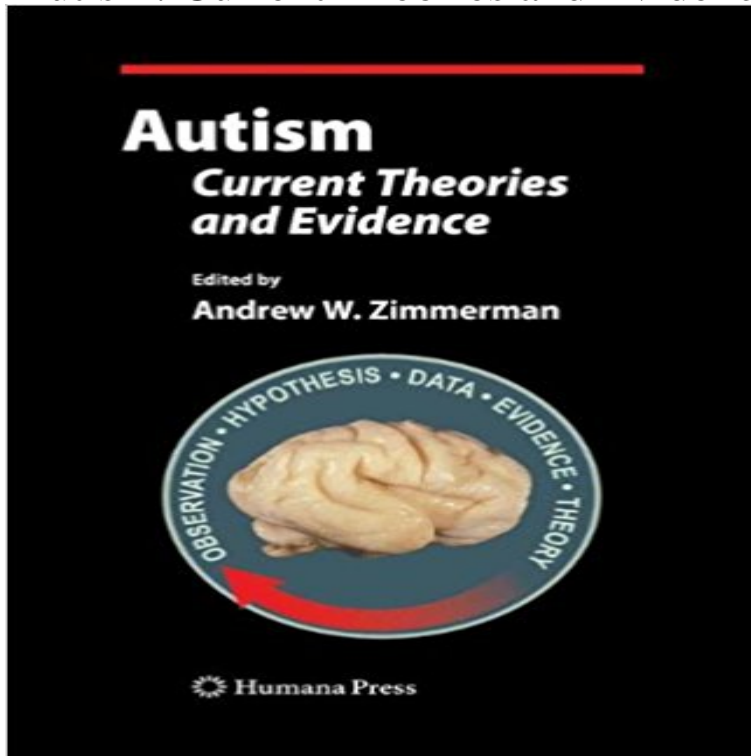


## Autism: Current Theories and Evidence (Current Clinical Neurology)

The reader is encouraged to consider how theories and the scientific method, in the hands of these and other dedicated researchers, are leading to greater knowledge and continued progress in autism research.
