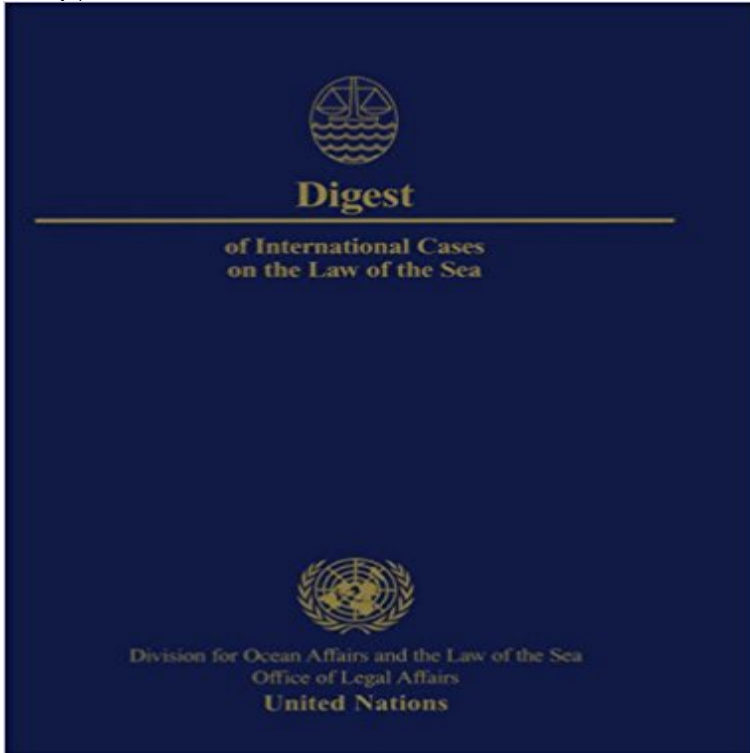


Digest of International Cases on the Law of the Sea
