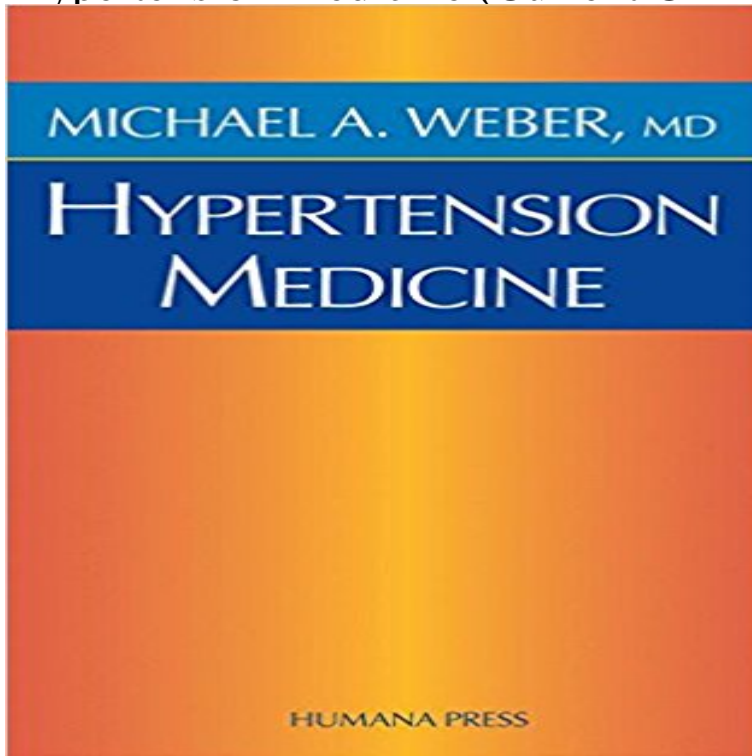


## Hypertension Medicine (Current Clinical Practice)
